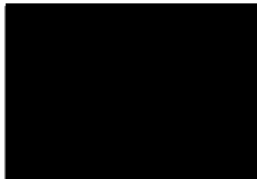

As per the Information Privacy Commissioner's recommendation to your Access to Information request, we would like to offer the release of the information detailed below.

The Information Privacy Commissioner of Nunavut has proposed that the following information can be disclosed without contravening the Act:


- a) *the Department that the application was made to*
- b) *pay range for the employee at the time the application was made*
- c) *the length of time for which the Education leave was granted*
- d) *how long each employee had been an employee when Education Leave had been granted (in yearly increments)*
- e) *the partial allowance in lieu of salary (expressed as a range – eg. Between 30 and 40 percent of pay or between \$30,000 and \$40,000)*
- f) *the terms of reference for all Departments' Education Leave committees.*
